Throughout 2019, he visited behavioral health clinics and met providers and clients to hear more about the importance of a strong service system. Members of Governor Lee's Cabinet have also been interested in understanding our service system and the challenges providers face in meeting the needs of Tennesseans. 





We're so excited to share our first quarter 2020 member highlight. Jimmie Jackson currently serves as the incoming TAMHO President. He is the Executive Director of Professional Care Services of West TN in Covington, Tennessee. Jimmie has worked for PCS for over 21 years, starting in October 1998. This was his first full-time job. He actually started to work in the accounting department while finishing his college degree, working his way from staff accountant, HR Director, and Compliance Officer, to become the CEO/Executive Director. One



of his favorite areas has been working to develop relationships with legislators and educating and keeping legislators informed on key areas impacting the behavioral health system. Jimmie holds an Associates degree in Accounting from Dyersburg State, a Bachelor's degree in Business with emphasis in Organizational Leadership from Union University, and an MBA with emphasis in Healthcare Administration from Freed-Hardeman University.

When asked about his favorite memories with PCS, Jimmie reports that it is hard to pick just one memory looking back at the last 21-years. He states, "I've been extremely blessed and fortunate to work with some really talented folks who are great individuals. I've enjoyed playing a small part in efforts to effectively advocate and tell the important story about the essential programs and services our agency has in each community". He further stated how that includes advocacy for TAMHO members across the state in addition to PCS. As he reflects, Jimmie says he smiles at the role he has had in working with such a great team to open new offices which has created greater access for behavioral health services and built new outpatient clinics in Ripley and Dyersburg that provide the infrastructure to carry out our mission to enhance the quality of life of every individual and family we treat. His favorite memories come from hearing their workforce members share their patient success stories and knowing the difference their workforce makes each day in all of their communities.

Jimmie's advocacy and outreach efforts recently included PCS hosting a visit by Tennessee Governor Bill Lee and TDMHSAS Commissioner Marie Williams and several TDMHSAS staff. This visit provided a highlight of the Behavioral Health Safety Net in action within their community. Jimmie relayed his pride in the PCS team and how they articulated the role PCS and other CMHCs play within our communities. Many of the local community stakeholders were on hand for this visit including law enforcement, school administrators, legislators, first responders, hospital staff, and many others. For a period of time, key community leaders where transfixed on behavioral health services and hearing first-hand the role CMHCs have in their community.

When asked if there was anything we might be surprised to learn about him, Jimmie shared his love of gardening and sharing the harvest with others. Each year he manages several fairly large gardens — mostly vegetables. They are a community garden but not in the aspect of shared work. Just like his commitment to advocacy for behavioral health and providing access within his community, Jimmie loves doing the gardening and then sharing the harvest with members in his community, church, and family. He shared, "Most years I'll have over 100 tomato plants along with other vegetables. I also enjoy growing pumpkins. I have 3 pumpkin patches in late summer and early fall with a variety of all types of pumpkins from pumpkin seeds I order from all over".

During his time away from PCS, he enjoys spending time with family and serving his church. He and his wife serve in the Gideon Ministry and are qualified speakers and work to distribute Bibles around the world. When asked about any favorite sayings or quotes, Jimmie shared, "I've always told my wife to 'stick with me and you will be alright' - so far for 25-years she has. I also often use the phrase from Dave Ramsey when people ask how I am by responding, 'Better than I deserve'". He further shared how he likes the phrase from Roman Philosopher, Lucas Seneca, "Luck is what happens when preparation meets opportunity" and the quote/phrase from Aristotle, "Be a free thinker and don't accept everything you hear as truth. Be Critical and evaluate what you believe in". As a Vol fan, he couldn't end without one last favorite - "It's football time in Tennessee" and "Give Him Six".

building. Several community organizations stepped up to help, including the Home Depot Foundation, which donated refrigerators and stoves.

Community members recently gathered for the grand opening of the new Boyette Memorial Apartments. The hope is that all eight tenants will be moved in by Christmas. "It would be a beautiful Christmas present," said Nelson.

Hervery describes the renovations as a two-year labor of love. She said CMI Healthcare Services is now planning future projects like this one. "This is just a little drop in the bucket of what our community actually needs, so we're hoping to do bigger and better," said Hervery.

### **TDMHSAS** announces grants to community-based agencies to create substance use disorder recovery housing

Grants to hire regional facilitators to leverage resources to create housing opportunities for people recovering from addiction to opioids and other substances

### **CONGRATULATIONS TO TAMHO MEMBERS** — **FRONTIER HEALTH AND HELEN ROSS MCNABB** CENTER

The Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS) is proud to announce five community-based behavioral





health agencies that will be instrumental in the state's efforts to increase housing opportunities for people recovering from substance use disorder.

The five agencies selected will receive new state funding to hire Regional Housing Facilitators under the department's new Creating Homes Initiative (CHI) 2 program. The facilitators are an essential part of the model working with community-based groups to inventory assets, identify needs, and create solutions.

CHI-2 looks to build off the department's highly successful

Creating Homes Initiative which has created more than 22,000 housing opportunities and leveraged more than \$692 million in state, federal, local, grant, foundational, and other sources for people living with mental illness. The original CHI was started in 2000 under the leadership of now-Commissioner Marie Williams.

"We are so excited, grateful, and humbled to bring this proven model of creating new housing options for vulnerable populations to the area of substance abuse recovery," said TDMHSAS Commissioner Marie Williams, LCSW. "Safe and affordable housing is an essential component on a person's journey to recovery, and this investment by Gov. Bill Lee and the Tennessee General Assembly will change the trajectory of countless lives for decades to come."

After a competitive grant submission and selection process, the following agencies were chosen to serve the following TDMHSAS planning regions:

- Upper East Tennessee: Frontier Health
- Knoxville / East Tennessee: Helen Ross McNabb Center
- Cumberland Plateau / Southeast Tennessee: Helen Ross McNabb Center
- Middle Tennessee (Outside Nashville/Davidson Co.) Coffee County Drug Court Foundation
- West Tennessee: Aspell Recovery Center
- Memphis/Shelby County: CAAP, Inc.

"We know that the addiction crisis in our state looks different depending on where you are. In spreading these housing facilitators across the state, we wanted to ensure that all Tennesseans who need recovery housing have access to an advocate who's working on their behalf," said Neru Gobin, TDMHSAS Director of Housing and Homeless Services.

In addition to the \$3 million in state funding budgeted by Gov. Lee and appropriated by the General Assembly in the department's FY20 budget, the Tennessee Housing Development Agency is matching the state's investment with \$3 million of their funding. THDA is accepting applications for this funding until January 16, 2020. More information at this link.

The remaining state funding to build and operate housing under CHI-2 and the Regional Housing Facilitator for Region 4, Nashville/Davidson County will be chosen at a later date after additional announcements of funding.

# TDMHSAS continues state leadership in expanding employment opportunities for people with disabilities

### New opportunity will bring national experts to Tennessee

The Tennessee Department of Mental Health and Substance Abuse Services (TDMHSAS) is continuing the state's leadership in improving employment opportunities for people with disabilities through a new grant award.

Tennessee is one of 13 Capacity Building States identified for the Visionary Opportunities to Increase Competitive Employment (VOICE) program through the U.S. Department of Labor Office of Disability Employment Policy. The grant represents technical assistance which will flow to community behavioral health providers who use the Individual Placement and Support (IPS) Supported Employment model to connect people with severe mental illness to competitive integrated employment opportunities.

"When we talk about employment for people living with serious mental illness, we're talking about a key that unlocks a future filled with hope," said TDMHSAS Commissioner Marie Williams,

LCSW. "Employment builds natural supports, increases self-worth and confidence, and develops independence for a person."

TDMHSAS has identified three areas of focus for the technical assistance opportunity:

- 1. <u>Expansion of IPS Services Statewide</u> update the current interagency agreement between DMHSAS and VR to expand IPS through VR's 4 to 1 match, Medicaid, TANF, and SNAP E & T funding.
- <u>Dual Diagnosis</u>- provide collaborative opportunities, resources, and training to mental health/IDD providers statewide to effectively support people with dual diagnosis (IDD + mental illness) who want to pursue competitive integrated employment.
- 3. <u>American Job Centers</u>- provide resources and guidance to create a cross-training for AJC staff members to more appropriately support people with disabilities, including people with behavioral health diagnoses.

The grant looks to build on the gains Tennessee has made as an Employment First State since 2012. In that year and every year since, Tennessee was awarded technical assistance through the predecessor of the VOICE Program. Previous opportunities focused on increasing competitive integrated employment and assist the state in moving away from segregated employment for people with disabilities.



Roberts's service in Tennessee state government began in 2013 joining TennCare as general counsel. He was promoted to deputy director and chief operating officer in 2016. Roberts was subsequently appointed by Governor Lee as director of TennCare in January 2019.

"It has been the honor of my professional life to serve the state of Tennessee during my seven years at TennCare and for serving alongside Governor Lee this past year," said Gabe Roberts. "I am thankful to my phenomenal wife and family for supporting me every day in my journey to serve our state and the members of the TennCare program. And I am indebted to my incredible team who has worked tirelessly with stakeholders across the state for so long to ensure that our Medicaid program remains on the leading edge of positive transformation, innovation, and fiscal sustainability. 

### Anthem, Aspire Exec Brad Smith to lead Medicare's Innovation Center

The Centers for Medicare and Medicaid Innovation (CMMI)'s new director is Brad Smith, the U.S. Department of Health and Human Services (HHS) announced Monday. Previously, Smith cofounded and worked as the CEO of the home-based palliative care provider Aspire Health before it was sold to national insurance giant Anthem in May 2018. He most recently served as the COO of Anthem's diversified business group, which Aspire became a part of. In addition to directing CMMI, Smith has been tabbed as a senior advisor to HHS Secretary Alex Azar. In his advisory role, Smith will specifically focus on value-based transformation, among other topics. U.S. Senate Health Committee Chairman Lamar Alexander spoke highly of Smith's background in a statement also released Monday. "Brad has exactly the right experience to lead a center charged with coming up with innovative ways to lower health care costs and improve quality," Alexander, a Republican from Tennessee, said. "He has founded a successful health care company and knows how state and federal governments work, having served under Governor Bill Haslam and Senator Bob Corker, and at the White House."

The CMMI works with Centers for Medicare & Medicaid Services (CMS) to innovate and develop health care payment and service delivery models that can reduce costs. The former director of CMMI, Adam Boehler, left the position in July when he was selected to lead the International Development Finance Corp. (DFC). Among his accomplishments, Boehler tried to reduce costs by emphasizing in-home and value-based care. "Brad is in the business of providing ideas and practical solutions to seemingly insurmountable problems," Former U.S. Senator Bill Frist told Nashville Public Radio (WPLN) in September. Frist co-founded Aspire Health with Smith in 2011. Smith will likely attempt to further innovate in the in-home and value-based care spaces where Boehler left off. "Brad's experience thinking outside-the-box to improve health care as a successful entrepreneur, along with his stellar academic and policy background, have prepared him well to lead CMMI and bring innovative solutions to our health care system's most pressing challenges," CMS Administrator Seema Verma said in a statement. "I am excited that we have selected Brad to join the ranks of CMS and help us build on the important work the Trump Administration has undertaken to transform our healthcare system to deliver better value to patients."

Senate Committee & FCC Unanimously Approve 9-8-8 Suicide Hotline Update

The National Suicide Hotline Designation Act (S. 2661) has passed unanimously out of the Senate Committee on Commerce, Science, and Transportation and now moves to the Senate floor. The bill would change the current, difficult to remember 10digit number for the national suicide prevention hotline to "9-8-8." Additionally, the Federal Communications Commission (FCC) yesterday unanimously voted in favor of a proposal that aligns with the Senate bill, and the change will soon be open to public comment.


