These policies apply to all events conducted by TAMHO whether produced as an independent TAMHO event or in partnership with another organization(s).



EVENT CODE OF CONDUCT - TAMHO is dedicated to providing a harassment-free event experience for everyone regardless of color, gender, gender identity and expression, sexual orientation, disability, physical appearance, body size, race, age or religion. TAMHO does not tolerate harassment of conference participants or staff in any form, including offensive comments, unwelcome advances, explicit jokes, or the use of sexual language and imagery. Conference participants violating these rules may be expelled from the event at the discretion of the conference organizers and/or TAMHO leadership. Each individual attending this event assumes all risks associated with his/her/their attendance and participation in all activities that occur during the event.
